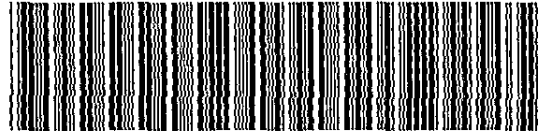

ARTICLES OF INCORPORATION FOR
