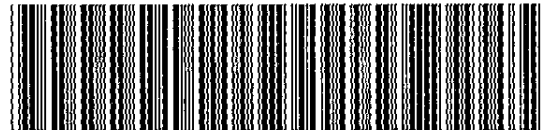

SHARES

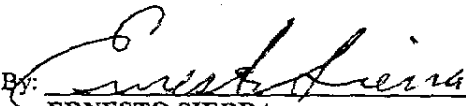
