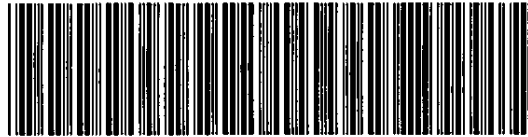

Pro-Link Global, Inc. ("Corporation").


**SECOND:** The Corporation's Articles of Incorporation were filed on January 26, 2006
