ARTICLES OF INCORPORATION OF SUPERIOR SPIRAL STAIRS, INC

ARTICLE I

Name. The name of this corporation is SUPERIOR SPIRAL STAIRS, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III
