**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
CARGO HOLDINGS INTERNATIONAL SERVICES, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, this **Florida Profit Corporation** adopts the following amendments to its Articles of Incorporation:

1. The current name of the corporation is CARGO HOLDINGS INTERNATIONAL SERVICES, INC.
2. The original Articles of Incorporation for the corporation were filed on January 30, 2006, effective January 23, 2006, and assigned Document No. P06000013592.
3. The Articles of Incorporation are amended as follows:
  - a. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

**ARTICLE I  
NAME**

The name of the Corporation is **LGSTX GROUP, INC.**

4. This Amendment will be effective as of the date of filing with the Florida Department of State.
