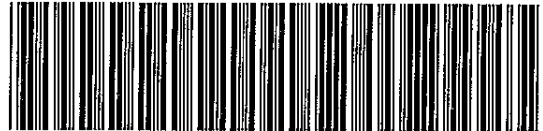

ARTICLES OF INCORPORATION

OF

ARTICLE 1. - NAME

The name of the corporation is FAST OUT, INC.

ARTICLE 2. - PRINCIPAL OFFICE


