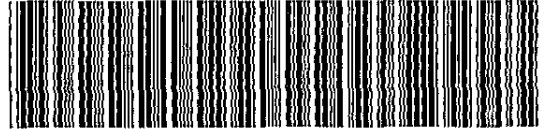

**ARTICLES OF INCORPORATION
OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation is **Professional Investigation Resources Corporation.**

PURPOSE
