The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I – NAME AND PRINCIPAL OFFICE

The name of the corporation is DynamicFX, Inc. The principal place of business and mailing address of the corporation is 12843 NW 23rd Street - Pembroke Pines, Florida 33028.

ARTICLE II - SHARES

ARTICLE IV – INITIAL OFFICERS AND DIRECTORS


The initial Board of Directors shall have two (2) members whose names and addresses are as follows:
