ARTICLES OF INCORPORATION

COLLINS MOBILE WELDING AND FABRICATION, INC.

The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is COLLINS MOBILE WELDING AND FABRICATION, INC., and the principal office and address is: 2321 URBAN RD. JACKSONVILLE, FL 32210.

ARTICLE II. NATURE OF BUSINESS
