**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
FLORIDA CONSUMER LAW GROUP, P.A.**

Pursuant to the provisions of section 607.1006, Florida Statutes, Florida Consumer Law Group, P.A., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation which were filed with the Florida Department of State on January 31, 2006, Charter Number P06000014270, and further amended on March 21, 2011 pursuant to Article XVI of its Articles of Incorporation:

**FIRST:** Article I of the Articles of Incorporation of the Corporation is amended in its entirety and restated as follows:

**Article I  
NAME**

The name of the corporation is **LAW OFFICES OF DEEB & DEEB, P.A.**

**SECOND:** Article VII of the Articles of Incorporation of the Corporation is amended in its entirety and restated as follows:

**Article VIII  
DIRECTORS AND OFFICERS**

The Board of Directors of the Corporation shall consist of two (2) Members. Changes in the number of Members comprising the Board of Directors shall be made by amendment to the Corporation's Bylaws.

The number of Directors set forth herein and constituting the initial Board of Directors shall be the authorized number of Directors until such number is changed by a bylaw duly adopted by the Shareholders.

The Officers of the Corporation shall consist of President, Chief Executive Officer and Secretary. Changes in the number of officers of the Corporation shall be made by amendment to the Corporation's Bylaws.
