ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, WESS JACOBS, hereby executes this document for the purposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following proposed Certificate of Incorporation:

ARTICLE I

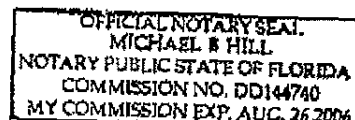
