

These Articles of Incorporation shall be effective immediately upon approval by the Secretary of State of the State of Florida.

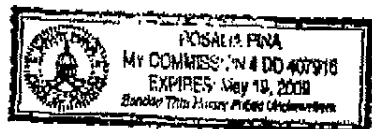
