ARTICLE I NAME

The name of the corporation shall be RK RESOURCES, INC.

ARTICLE II PRINCIPAL OFFICE

The address of the principal office of the corporation is 24 W. 8th Street, Panama City, Florida, 32401.

ARTICLE III DURATION

The corporation shall have perpetual existence, commencing on the date of execution and acknowledgement of these Articles or upon filing.

ARTICLE IV PURPOSE
