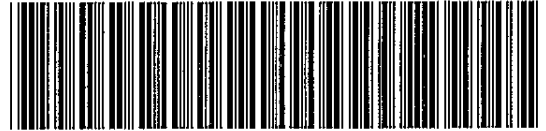

PREEMPTIVE RIGHTS:**



AMENDMENT :**


