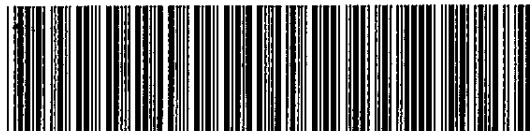

**ARTICLE I

DURATION**
