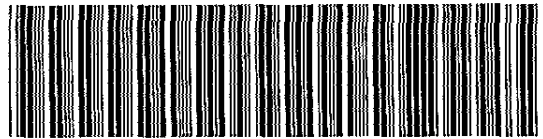

CUMULATIVE VOTING




