#### ARTICLES OF INCORPORATION

The undersigned incorporator, who is licensed or otherwise legally authorized to practice the profession of chiropractic care in the State of Florida, associates with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, and adopts the following articles of incorporation for the corporation:

I.

The Name of the corporation shall be:

The address of the principal office of the corporation and the mailing business address of the corporation shall be:

III.

This corporation is organized for the following purposes:

- a. To engage in the practice of chiropractic health care facility as a professional corporation and to own and operate, as necessary in its sole discretion, a chiropractic health care facility for the purposes of providing chiropractic care and treatment.
- b. The aforestated powers are not limitations, but the corporation shall have any and all powers that under the laws of the State of Florida and a liberal construction of the aforestated powers, can be granted to a corporation of this nature.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional dental or periodontic services in the State of Florida.

The amount of capital with which the corporation will begin business will be no less than Five Hundred and No/100 (\$500.00) Dollars.
