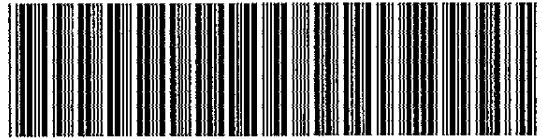

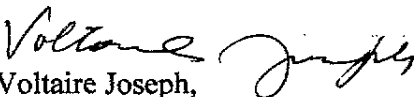

# ARTICLES OF INCORPORATION OF

## VOLTAIRE VENTURES INC.

The undersigned subscriber to these articles of incorporation is a natural person competent to contract and hereby form a corporation for profit under chapter 607 of the Florida Statutes.

### ARTICLE I Name of Corporation

The name of this corporation is VOLTAIRE VENTURES INC..

### ARTICLE II Purpose

This corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida, and approved by the Board of Directors.
