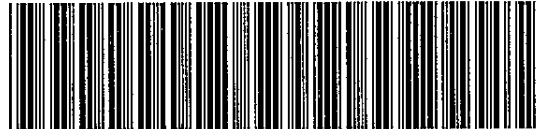

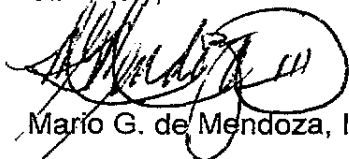

Article I - Name

The name of this corporation is SUNNYMEADE, INC.

Article XII - Shareholders' Meeting

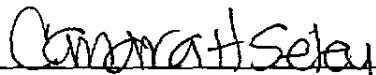

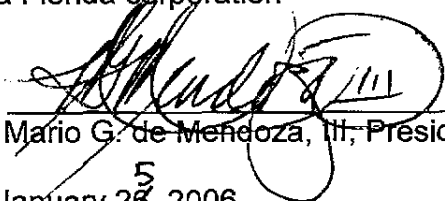
