

ARTICLES OF INCORPORATION



OF

LATITUDES OF JACKSONVILLE, INC.

I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I

Name and Principal Address

The name and principal address of the corporation shall be: LATITUDES OF JACKSONVILLE, INC., 1257 Ribbon Road, Jacksonville, FL, 32259. The mailing address shall be the same.

This corporation shall have perpetual existence.
