ARTICLE 1

NAME

The name of this corporation is: Hendricks Printing Company

ARTICLE 2

DURATION

The number of directors may be changed from time to time in accordance with the bylaws.

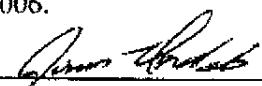
