

ARTICLES OF INCORPORATION

OF

JOSEPH B. STANTON, P.A.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a professional service corporation for profit pursuant to Chapter 621 and Chapter 607 of the Florida Statutes.

ARTICLE I - Name

The name of the Corporation shall be:

JOSEPH B. STANTON, P.A. (the "Corporation").

ARTICLE II - Principal Office

The address of the principal office and the mailing address of the Corporation is 390 North Orange Avenue, Suite 1100, Orlando, Florida 32801.

ARTICLE III - Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida. Provided, however, and notwithstanding the generality of the foregoing, the Corporation is not to conduct a banking, safe deposit, trust, insurance, surely, express, milroad, canal, telegraph, telephone or cometery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

ARTICLE IV - Capital Stock

A. The authorized capital stock of the Corporation and the maximum number of shares of stock that the Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of \$.01 per share.

ARTICLE V - Term of Existence

The effective date upon which the Corporation shall come into existence shall be the January 23, 2006, and it shall exist perpetually thereafter unless dissolved according to law.

ARTICLE VI - Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 390 North Orange Avenue, Suite 1100, Orlando, Florida 32801 and the name of the initial registered agent of the Corporation at that address is Joseph B. Stanton.

ARTICLE VII - Directors
