**ARTICLES OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, Providing for the formation, rights privileges immunities and liabilities of incorporation for profit.

ARTICLE I
