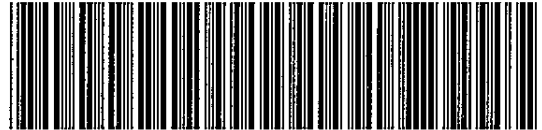

**R.M.C. PROPERTY MANAGEMENT, INC., A FLORIDA CORPORATION FOR**  
**PROFIT**

**ARTICLE I - NAME**

The name of the corporation shall be: R.M.C. Property Management, Inc.

**ARTICLE II - PRINCIPAL OFFICE**
