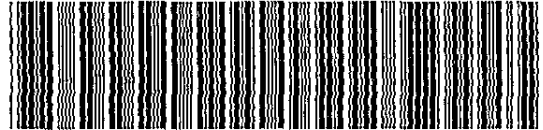

**ARTICLES OF INCORPORATION
OF
Plantation Homes of Central Florida, Inc.**

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

1. **Name.** The name of this corporation is Plantation Homes of Central Florida, Inc.
2. **Purpose and Powers.** This corporation is organized for the transaction of any and all lawful business. This corporation shall have the broad general powers set forth in Florida Statutes regarding a for profit corporation.
3. **Authorized Shares.** The corporation shall have the authority to issue 1000 shares of common stock. The par value of the stock is \$ 1.00.

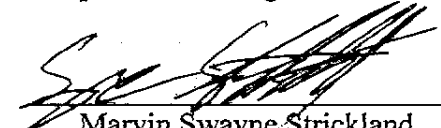

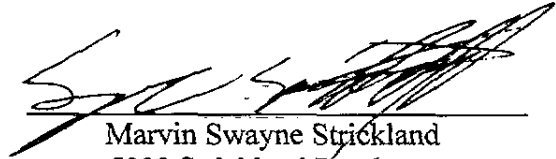
