COMMENCEMENT OF EXISTENCE**

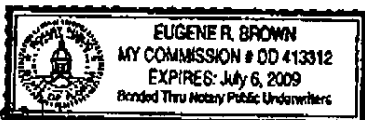

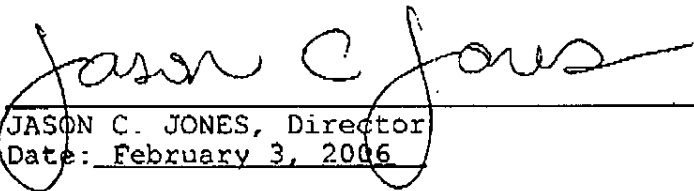

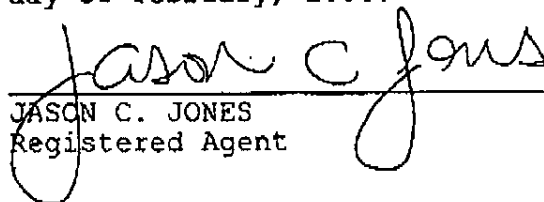
