In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, *does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.*

**ARTICLE I**

The name of the corporation ("Corporation") is **COCOA VILLAGE REALTY OF BREVARD, INC.**

**ARTICLE II**


