





ARTICLES OF INCORPORATION OF D.C. TILE & CARPET, INC.



ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is D.C. TILE & CARPET, INC., and the principal address and principal place of business is 30333 U.S. HIGHWAY 19 NORTH, CLEARWATER, FLORIDA 33761.

ARTICLE II - REGISTERED OFFICE AND AGENT
