



#### ARTICLES OF INCORPORATION

OF



#### BERNIER RESIDENTIAL APPRAISAL GROUP, INC

I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

### ARTICLE I Name and Principal Address

The name and principal address of the corporation shall be: Bernier Residential Appraisal Group, Inc., 13132 Tamarisk Court, Jacksonville, Florida 32246. The mailing address is the same.

### ARTICLE II Duration

This corporation shall have perpetual existence.

### ARTICLE III Purpose

The general nature of the business to be transacted by this corporation is as follows: To conduct real estate appraisals

and to do all things which are authorized to be done by corporations organized under the laws of the State of Florida.

### ARTICLE IV Capital Stock

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1000) shares. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

### ARTICLE V Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI Initial Registered Office and Agent

## ARTICLE XII Corporation Business
