ARTICLES OF INCORPORATION
OF
COLTRAN TRANSPORT, INC.

The undersigned incorporator hereby associates himself to form a corporation under Chapter 607, Florida Statutes.

ARTICLE I

NAME

The name of the corporation is COLTRAN TRANSPORT, INC. and the address of the corporation is, 16532 SE 152nd PLACE RD., WEIRSDALE, FL 32195

ARTICLE II

GENERAL PURPOSE

The general purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE III

CAPITAL STOCK

The aggregate number of shares of stock which the corporation shall have the authority to issue is 60,000 shares of common stock having a par
