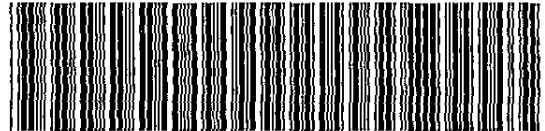

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
METROVISTA ACQUISITION CORP.**

METROVISTA ACQUISITION CORP., a Florida corporation (the "Corporation"), by and through its President, hereby adopts an amendment to its Articles of Incorporation of February 3, 2006, as hereinafter set forth.

1. Pursuant to Section 607.1003 of the Florida Statutes, the Board of Directors of the Corporation and the shareholders of the Corporation, in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on March 31, 2006, adopted an amendment to Article I of the Articles of Incorporation of the Corporation. Article I is deleted in its entirety and the following is substituted therefor:

**ARTICLE I
NAME**

The name of this Corporation shall be:

METROVISTA, INC.

2. Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.
