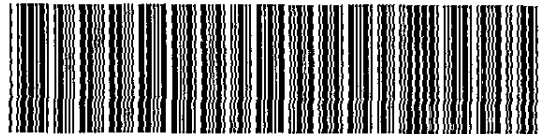



ARTICLES OF INCORPORATION

ARTICLE I – NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **BIG TROUBLE BBA, INC.**, and its principal place of business shall be located at **416 SOUTH MILITARY TRAIL, SUITE A, WEST PALM BEACH, FLORIDA 33415.**

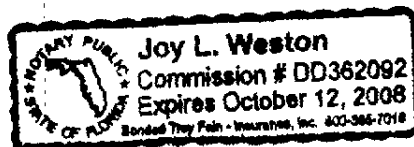
