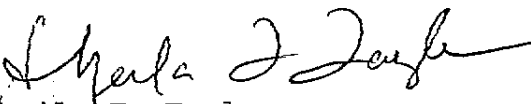

ARTICLES OF INCORPORATION

OF

S & W CONTAINERS, INC.

ARTICLE - I

The name of this corporation is: **S & W CONTAINERS, INC.** The principal office of this corporation is located at 6091 Hialeah Drive, Pace, Florida 32571, and its mailing address is Post Office Box 1093, Pace, Florida 32571.

The term of existence of the corporation is perpetual.

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.

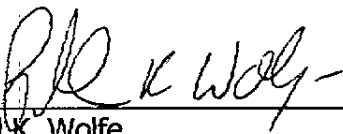
ARTICLE X - AMENDMENT
