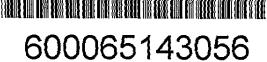

#### **S & W CONTAINERS, INC.**

#### ARTICLE - I

The name of this corporation is: **S & W CONTAINERS, INC.** The principal office is this corporation is located at 6091 Hialeah Drive, Pace, Florida 32571, and its mailing address is Post Office Box 1093, Pace, Florida 32571.

#### ARTICLE - II

The term of existence of the corporation is perpetual.
