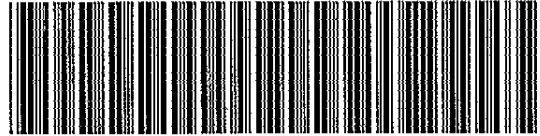

ARTICLE ONE

The name of the corporation is REAL ESTATE CONNECTION OF SARASOTA, INC.

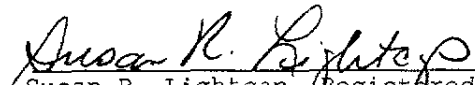
