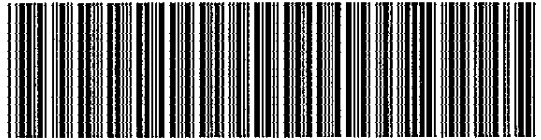

**ARTICLE I**

**Name**

The name of the corporation shall be: **Real Estate
