

I, the undersigned, as a proper person acting as an incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

First

The name of the corporation will be Nancy Arleen Montford, P.A.

Second

The period of its duration is in perpetuity.

Third
