The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a professional service corporation accordance with the laws of the State of Florida, effective as of February 7, 2006.

**ARTICLE 1
NAME**

**ARTICLE 11
BYLAWS**

The power to adopt the bylaws of this corporation, to alter, amend or repeal the bylaws, or to adopt new bylaws, shall be vested in the Board of Directors of this corporation.

AMENDMENT OF ARTICLES OF INCORPORATION**


