

For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of this corporation is HUERTA'S SCREENS, INC.

**ARTICLE II. DURATION**

The duration of this corporation shall be perpetual.

**ARTICLE III. PURPOSE**

The purpose of this corporation shall be repairs of screens, and any other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.


