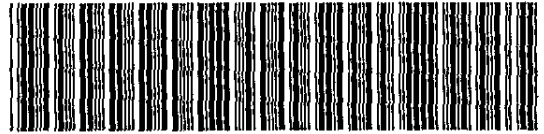

## ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, adopt the following Articles of Incorporation:

#### ARTICLE ONE NAME
