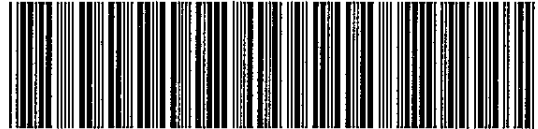

ARTICLE 1 NAME

The name of this Corporation (which is hereinafter called the "Corporation") is: AFRICAN APPAREL AND 99 CENTS STORE, *Incorporated*

ARTICLE 11 ADDRESS
