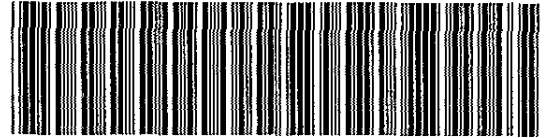

The undersigned incorporator to these Articles of Incorporation, being a natural person competent to contract under the laws of the State of Florida, hereby forms a corporation for profit under Chapter 621 of the Florida Statutes, referred to as the Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

**ARTICLE I
Name**

The name of this Corporation is **BP FIRM, P.A.** The street and mailing address of the Corporation is 8723 Thornwood Lane, Tampa, Florida 33615.

**ARTICLE II
Term of Existence**

This Corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation with the Florida Secretary of State.

**ARTICLE III
Purpose**

The general nature of the business to be transacted by this Corporation, together with and in addition to those powers conferred by the laws of the State of Florida upon corporations organized under the laws of Florida, shall be as follows:

1. To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney, duly licensed under the laws of the State of Florida, is authorized to render, but such professional service shall be rendered only through officers, employees and agents of this Corporation who are duly licensed or otherwise legally authorized under the laws of the State of Florida to perform said services.
2. To transact any or all other lawful business for which a professional service corporation may be incorporated under the Florida Professional Services Corporation Act and the Florida General Corporation Act.

**ARTICLE IV
Capital Stock**

The Corporation is authorized to issue 10,000 shares of \$0.0001 par value common stock, which shall be designated Common Stock.

Initial Registered Office and Agent
