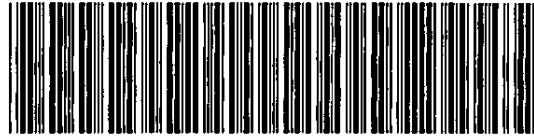

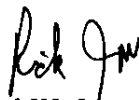

Effective the date hereof, Article I of the Articles of Incorporation of PAYDAY USA - FLORIDA, INC. is amended to read as follows:

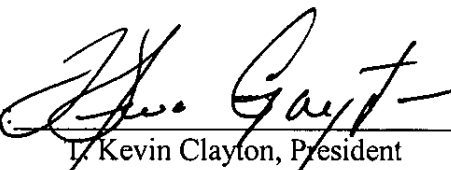
The name of the Corporation is Payday USA, Inc.
