#### ARTICLES OF INCORPORATION

# SHADE SAILS, INC. A Florida For-Profit Corporation

THE UNDERSIGNED, acting as the Sole Incorporator of a corporation being formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation for the corporation:

## Article I - Name

The name of this corporation is Shade Sails, Inc. ["Corporation"].

## Article II - Principal Place of Business

This Corporation's principal place of business is 1821 North "P" Terrace, Lake Worth, Florida 33460.

## Article III - Duration

This Corporation's duration is perpetual.

## Article IV - Purpose and Power

its own shares, and to e receise as owner or holder of any securities, any and all rights, powers and privileges in respect thereof.

- D. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of anyone or more of the subjects herein chumerated, or which may at any time appear conducive to or expedient for the protection or benefit of this corporation, and to do said acts as fully and to the same extent as natural persons might, or could do, in any part of the word as principals, agents, partners, trustices or otherwise, either alone or in conjunction with any other person, association or corporation.
- E.
