



ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Cruz Carona & Associates Investments, Inc. and its principal place of business shall be located at 8606 Villa Nova Road, Orlando, FL 32817.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.


ARTICLE XI - AMENDMENT

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the Shareholders.




