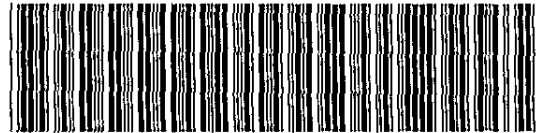

## ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these articles of incorporation, being duly a licensed real estate broker under the laws of the State of Florida, adopts these articles to form a corporation under the Florida Business Corporation Act, the Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

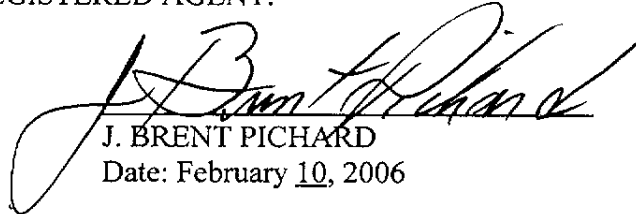
