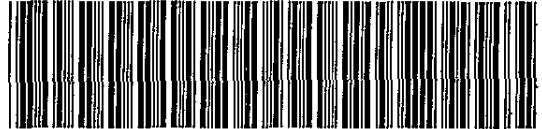

**ARTICLE I
NAME AND ADDRESS**

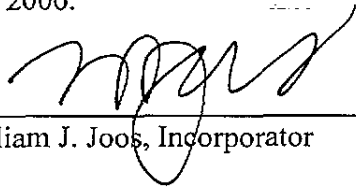
**ARTICLE IX

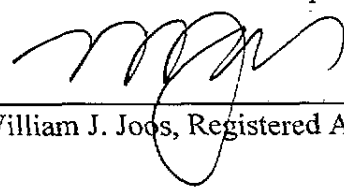
