OF

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

#### ARTICLE I NAME

The name of this corporation is: ALL EASY INVESTMENT CORPORATION

#### ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this Corporation shall be: 9450 SUNSET DRIVE UNIT 101 MIAMI, FLORIDA 33173.

#### ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:
