FINAL JUDGMENT OF SIMPLIFIED DISSOLUTION OF MARRIAGE

THIS CAUSE came before this Court for a hearing on the parties' petition for Simplified Dissolution of Marriage on Friday, January 26, 2007. The Court, having reviewed and heard the testimony, makes these findings of fact and reaches these conclusions of law:

1. The Court has jurisdiction over the subject matter and the parties.
2. At least one party has been a resident of the State of Florida for more than 6 months immediately before filing the Petition for Simplified Dissolution of Marriage.
3. The parties have no minor or dependent children in common, and the wife is not pregnant.
4. The marriage between the parties is irretrievably broken. Therefore, the marriage between the parties is dissolved, and the parties are restored to the status of being single.
5. The parties have voluntarily entered into a Marital Settlement Agreement, and each has filed the required Financial Affidavit. Therefore, the Marital Settlement Agreement is filed as **Docket Entry #7**, in this case and is ratified and made a part of this judgment. The parties are ordered to obey all of its provisions.
6. The wife's former name shall be restored to **DEBORAH LYNN FLOWERS**.
7. The Court reserves jurisdiction to enforce the marital settlement agreement.


