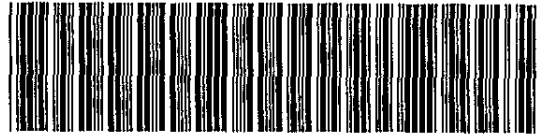

ARTICLE I
